If your tank has any one of these defects, you're not meeting your obligations to store fuel safely...

FACTSHEET



As farmers, you are required to safely store and handle fuels so that they are not a source of pollution for the environment, or a source of harm to employees, your family, and yourself. Safe fuel storage also makes financial sense – no more paying good money for fuel wasted through leaks, drips and spills!

The Department of Labour and the Environmental Protection Authority have joined together to produce a revised guide that gives you all the information you need to fulfil your legal obligations to store and handle fuel safely under the Hazardous Substances and New Organisms Act 1996 and the Health and Safety in Employment Act 1992. It's called the *Guide for Above-Ground Fuel Storage on Farms*.

Here is a summary of the minimum requirements for safe above-ground fuel storage and handling:
